

# **COVID-19 FIRE INSPECTION SUSPENSION GUIDELINES**

In an effort to protect the general public and the employees of all Marin County Fire Agencies, and reflective of the <u>shelter in place order</u> issued March 16, 2020 by the Health Officer of the County of Marin, effective immediately, requests for all non-essential fire inspections have been suspended.

The intent of this suspension is to respect the county order to shelter in place, limit personal contact and exposure, and to slow the spread of COVID-19 to the maximum extent possible.

# The following fire inspections have been determined to be non-essential and will be suspended:

 All construction inspections including, but not limited to, verification of project scope (close-in), fire protection systems in new or remodel construction, vegetation management, photovoltaic, generator, ESS/battery systems, and final fire construction inspections are suspended.

### The following fire inspections will be evaluated and scheduled as needed:

- Essential fire inspections needed to approve maintenance and repair of existing fire protection systems.
- Investigation and/or inspection of reported hazardous conditions that impact fire protection systems or that reflect a threat to life safety.
- Persons reporting a hazardous condition shall be required to email the local fire agency (see reverse for contact information) with a request to investigate hazardous conditions. The request shall include the reporting party's name, address and phone number, the name of the property owner where violation is occurring (if possible), address, a brief narrative of the issue and photos or videos.
