This standard has been developed pursuant to Section 904.2 of Title 19 of the California Code of Regulations. This standard is intended to be used as a guide for compliance with the servicing requirement of Title 19 as it relates to Automatic Fire Extinguishing Systems.

I. General

- A. Section 904.2, Title 19, requires that all servicing done to Automatic Extinguishing systems be done by companies licensed by the California State Fire Marshal.
- B. Additionally the State Fire Marshal has agreed with the State Contractors License Board that any companies licensed by the contractors board with a C16 license may perform the service requirements.
- C. There are three (3) classes of licenses available from the State Fire Marshal:
 - 1. Type 1 – Can service fire sprinkler systems
 - 2. Type 2 – Can service other types of automatic systems including dry chemical, wet chemical and halon engineered and pre-engineered systems.
 - 3. Type 3 – Can service standpipe systems

II. Licensed Concerns

The following is a list of licensed concerns in our area that can provide the servicing required by Title 19. The companies listed are possible not the only listed concerns providing this type of service. The list was compiled by using the State Fire Marshal's Office Listing of Approved Concerns dated April, 1988 and the Marin County telephone directory for the C-16 contractors. The list contains only those companies that indicated a willingness to provide service in the San Rafael area. The Fire Loss Management Division and the Kentfield Fire Protection District do not represent, endorse or recommend any of the mentioned companies or their service; but rather supply this information for the purpose of service availability pursuant to the requirements of Title 19 of the California Code of Regulations.

Reiterating an earlier point for Type 2 systems, the contractors also have to be specifically licensed for each brand and size of system they wish to service. For C-16 contractors, the Kentfield Fire Protection District will require a letter from the manufacturer of the specific system indicating authorization to service their product.
