The Board entered a Closed Session at 6:34 p.m.

The Board adjourned and entered back into Open Session at 7:04 p.m.

Director Murray addressed A-Shift and the KAPF members on zoom. He discussed the Board's position regarding the KAPF Labor negotiations and asked those who were present to convey the Board's message to the entire Association. He explained the total compensation package received by the KAPF Association was already the top in Marin County and Measure G Tax funds could not be used toward personnel costs. Kentfield Fire District has \$6.7 million in unfunded liability with CalPERS. Director Murray stated it is the District's fiduciary responsibility to the community to maintain the funds and plan for the future. He expressed the Board's appreciation and respect for the KAPF Association. He hoped they would understand the Board's thoughts and feelings.

Director Gerbsman stated the Board is offering the Association a 3% raise increase. Director Murray explained the Board was willing to go up to a 3.5% raise increase with an MOU change for new hires. Any new hires would have a medical premium baseline of Kaiser. Director Gerbsman conveyed part of the reason for having this open dialogue was to share how the Board is feeling and why. He hoped the Board and the Association could come to a reasonable conclusion at the next subcommittee meeting. Captain Viau thanked the Board for their honesty. He expressed how much the Association respected the Board and would convey the message.

Engineer Tescallo clarified that it was never the Association's intent to increase the Measure G Tax for raises. With a \$70k increase in communications the proposed idea was to increase Measure G to help cover expenses so there wasn't a 10% cut on most budget items.

Director Evergettis stated he was looking forward to meeting with the Association subcommittee on Friday and hoped the information discussed tonight could help.
