**AGENDA ADJUSTMENTS:** Chief Pomi requested Agenda item 8, Chief's Report, will be moved above Unfinished Business. The Board approved.

#### **CHIEF'S REPORT:**

- a. Accountant Introduction Introduced Accountant Phillip Chavira to the Board. He has been with KFD a little over a month and is going to be an amazing asset to the team. Accountant Chavira spoke briefly about some of the local agencies he works with, while providing background information on past work he has completed. He will continue training with Accountant Hom through December.
- b. Final Audit In September, Maze & Associates completed the final phase of the audit. The auditors have sent a draft presentation of the basic financials and the District is in the review process. The District is anticipating Maze & Associates will be presenting the audit results at the December Board meeting.
- c. MERA This past week a great milestone in the County was reached. All agencies have cut over to the new radio system; MERA Gen1 is now in the MERA Gen2. The past 14 years Director Naso sat on the board alongside 26 other agencies. Some small issues are being worked through but overall the system is working as designed.
- d. KFD Open House Just a reminder, this Saturday is Kentfield Fire District's Open House; 10am to 2pm. The staff have been planning this event and working on getting the facility cleaned. The Greenbrae Historical Society, members of the MWPA Defensible Space Program, and Marin Get Ready from OEM will all be partnering with KFD and present at the Open House. Members of the community can expect to see the Kentfield Fire staff, station equipment, bounce houses, games, food, and prevention swag for the kids. Everyone is welcome.

#### SPECIAL ANNOUNCEMENTS/PRESENTATIONS: None

#### **UNFINISHED BUSINESS:**

a. Roof Repair at Station 17 – Chief Pomi referred to his staff report which included a bid proposal from Wedge Roofing. Since the station was remodel 15 years ago, the roof has been problematic with leaks and repairs. To avoid permanent structure damage, some minor and major repairs have been done to keep water out of the station. The past two winters, significant leaks in the apparatus bay were detected and are under the solar panel. With the roof being the design that it is, a flat roof, the water pools underneath the solar panel and works through the seams and drips down on the equipment. The District began to do emergency repairs with Wedge Roofing and were able to slow the leaks but not able to completely stop the leaks. Engineer Bridges put together a plan on how to repair and replace parts of the roof in portions instead of doing both the whole roof at one time. The HVAC equipment sits on the east

side of the roof, while the solar panels lay on the west side is. Different design plans were looked at and bid upon. The Wedge Roofing bid includes taking the roof membrane and adding foam to allow the roof to slope away from the center and back to the drains. In addition, there will be a curb built that will go along the separation point between the inside living area and the apparatus. If approved, everything on the west side would be completed. The second phase of the project would include the solar farm which consists of 68 panels. The panels need to be removed in order to repair the roof. The District took the opportunity to evaluate the current solar system, have multiple consultant discussions, and receive bids on new technology. After a thorough review, the best mode of action would be to remove the current system, repair the roof, and then replace the solar system. Wedge Roofing can get the roof completed before the winter. The total cost of the project for the repairs, the new roof, the foam, the warranty, the removal of the panels, and then the replacement comes to about \$114k. Chief Pomi asked for Board approval of the Wedge Roofing bid. He asked if there were any questions. After much discussion the Board agreed to move forward with the bid proposal.

#### **NEW BUSINESS:**

a. Annual Gann Appropriations Limits Report - Chief Pomi gave an overview of the Annual Gann Appropriations Limited report provided in the BOD packet. He stated the California appropriations limit, also known as the Gann initiative, is the maximum amount of money that the Fire District can legally spend. Proposition 4 was approved by the voters back in November of 1979 with a purpose to set limits on the growth of expenditures for publicly funded programs. Each year the District is required to reevaluate the appropriations limit with the ability to increase it by the rate of population increase and the rate of inflation. Chief Pomi referenced page 3 of the document titled Kentfield Fire Protection District Property Tax Appropriations Limit Fiscal Year 2023-24 and provided a summary. He explained the Appropriation Limit for 2022-23 was roughly \$3.8m and the adjustment for 2023-24 is 3.3329%. The Property Taxes (secured and unsecured) amounted to \$6,101,403. The Special Assessment at \$878,798 is a calculation of Measure G and Measure C (MWPA). Supplemental Assessments are at \$117,636 and are non-property. Aide Other Governmental Agencies is the excess Educational Revenue Augmentation Fund (ERAF) or monies that were returned to the Fire District in the fiscal year and it equated to \$427,572. The Proceeds of Taxes amounted to \$7,525,409 and the Allocation (growth calculation) was \$672,789. The total plus the allocation of growth provides an Appropriations Limit for the fiscal year 2023-24 of \$8,198,198. Chief Pomi explained once this report was approved by the Board, it will be provided to Maze & Associates for the year-end audit.

b. 2024 Biennial Notice - Conflict of Interest Code – Kentfield Fire District is required through the State Political Reform Act to adopt a Conflict of Interest Code. Chief Pomi explained this corresponds to the Statement of Economic Interests (Form 700) which is filed every year not only for the Fire District, but for any other governing board a member is a part of. Resolution 6-2014 states the District will follow all regulations and Attachments "A", "B", and "C" are in accordance with the requirements. Attachment "A" confirms the Board of Directors, the Fire Chief, and the General Counsel are those who need to fill out Form 700. Attachment "B" states all sources of income, interests in real property and investments would be disclosed, and attachment "C" displays the place of filing. This is a District administrative task which takes place every two years. Once the Conflict of Interest Code is approved, the District completes the application with no amendments required. It is then filed with the County of Marin. Chief Pomi asked if there were any questions. None were asked.

All CMFD stations are providing to the public individual mail kits to assist with the disposal of old or expired medications. Also, providing a product called Dosetest to the public to test medications /drugs for Fentanyl.

New services offered at all Central Marin Fire stations:

Central Marin Fire has partnered with agencies from Marin County to offer a program to mail in old or expired medications. It is hazardous and harmful to throw away or flush medications. This program will allow a safe and easy way to dispose of medications. You can also drop off your medications at the Central Marin Police Department. It is important to note that our fire stations DO NOT accept old medication of any kind but will provide you the mail in kit.

The second service is Dosetest. A program

designed to save lives by testing drugs prior to use. In this last year alone, they have given away over 3 million test kits in their attempt to save as many lives as possible.

These services can be picked up at any of our 4 Central Marin Fire stations during the hours of 8 AM and 5 PM. Please note that personnel may be on calls for service and may not be at the station at certain times.

# Ross seeks delay in fire station closure

Ross is asking the Ross Valley Fire Department for a one-year delay in the closure of Station 18 because of concerns about paramedic services.

A letter from the town to the fire board says Ross officials want to explore paramedic coverage options because of uncertainty about the Ross Valley Paramedic Authority finances if Larkspur and Corte Madera leave the agency.

At issue is a request made earlier this year by officials in Larkspur, who asked that a planned fiscal analysis of the authority consider a change in the contract to exclude Larkspur and Corte Madera, which would instead receive service from the Central Marin Fire Department.

The move "might better align governance to the stewardship of jurisdictionally-generated taxes and resources," Larkspur City Manager Dan Schwarz wrote in a letter to Marin County Fire Department Chief Jason Weber, the paramedic authority's executive officer.

The Ross Valley Paramedic Authority, created in 1982, operates on a \$3.3 million budget funded by parcel taxes in member communities. It provides emergency services to Corte Madera, Fairfax, Ross, San Anselmo, Larkspur, Kentfield, the Sleepy Hollow Fire Protection District and unincorporated pockets in the Ross Valley.

The Ross fire station, built in 1926, is considered outdated and is scheduled to close by July 1.

Ross Councilmember Elizabeth Robbins, one of the town's representatives on the fire board, said the absence of emergency medical responders in Ross would be unacceptable and would place residents at risk.

In the letter to the fire board, Ross Town Manager Christa Johnson wrote that when the Station 18 closure was agreed upon in 2021, it was unknown that the paramedic authority might be in jeopardy.

"Three years later, the fragility of the RVPA JPA is clear and its viability is in question," the letter said. "It is reasonable to request a one-year delay in the closure of Ross Fire Station 18 so that every member of the RVFD and the RVPA can determine how best to maintain adequate levels of emergency medical response in the greater Ross Valley."

Johnson said the departure of paramedic service would result in a two-minute increase in response time. An estimated 10-minute response time is considered an "edge suburban to rural level of response" and would be a significant decrease in service to the area, she said.

Amendments to the JPA would require approval by each member's governing body before being considered by the fire board.

The Ross Valley Paramedic Authority has operated one of its two paramedic ambulances out of the Ross fire station since the early 1980s, according to a staff report.

A master facilities plan adopted by the council in 2023 included a new paramedic ambulance facility at an estimated cost of \$2 million. The potential costs have dramatically increased since then, the staff report said, and the plans are on hold.

The town and the Ross Valley Paramedic Authority have had four-year leases for use of town facilities since 1982. The paramedic authority prefers the four-year lease because that is the term of its main funding source, a parcel tax, according to a staff report.

The latest four-year lease involving Ross, the Ross Valley Fire Department and the paramedic authority expired on June 30, but it has been was extended to Dec. 31.

Weber said the paramedic board would receive the fiscal analysis report, which would evaluate the potential change in jurisdictional boundaries, on Nov. 7.

"I am confident we are going to be around for another 40 years providing excellent service," he said. "We will work this out."

Ross Valley fire Chief Dan Mahoney said he looks forward to the presentation on Nov. 7.

"I am confident that the results of the study will provide RVPA board members the information that is needed to have informative deliberations and have confidence the RVPA will continue to provide excellent services to all communities served," he said.

The Ross Valley Fire Department is funded by member contributions of \$3.3 million from Fairfax; \$2.8 million from Ross; \$5.7 million from San Anselmo; \$1.8 from Sleepy Hollow and outside revenues of \$1.1 million, according to the 2024-25 budget.

Update on the Lower College of Marin Corte Madera Creek Restoration Project

Hi Mark and Larry,

The project to restore a portion of Corte Madera Creek to a natural condition by removing parts of the concrete channel at College of Marin, located downstream of the Stadium Way Bridge, has obtained adequate funding for (de)construction to proceed in late summer/early fall of 2025. Friends of Corte Madera Creek Watershed, Marin County Flood Control and Water Conservation District, and College of Marin have been working on this project for several years—this is a major milestone.

Plant propagation is underway and the preparation of a Request for Proposals will start in late 2024. The goal is to hire a contractor no later than the end of February 2025 so construction can start in summer 2025. All planning, environmental documents, and permits have been secured. The first work in the field, in August 2025, will be site preparation (including project signs), hand salvage of wetland plants, clearing and grubbing of trees and shrubs and equipment mobilization. In-channel work, starting with installing coffer dams to dewater the work area, can begin September 1, 2025. After that, it will be full steam ahead with excavation and removal of concrete, followed by establishing the final grade for the restored creek and habitat areas. The project has been designed to be resilient to climate change and sea-level rise. Project (de)construction is estimated to take four to six weeks; in-channel work must be completed by mid-October. Installing native wetland, transition zone, and upland plants, fencing, signage, and repairing paving can take place later.

Construction access to the work area will be from Kent/College Avenue intersection through College of Marin parking lots to the existing Flood Control District easement. Route 20, the paved Multi-Use Path on the left bank of the creek (looking downstream), will remain open during construction. The informal dirt path on the right bank of the creek will be closed during construction and relocated to a location between the restored area and the College of Marin Maintenance and Operations building. It will open after the fencing is installed.

The work is being funded in large part by generous grants from the California Coastal Conservancy, US Fish and Wildlife Service, Marin County, and the National Fish and Wildlife Foundation.

## Protecting Those Who Protect Us: An Urgent Effort to Protect Marin Firefighters from Cancer-Causing Chemicals

On a clear morning last May a long row of fire trucks lined the shore of Fort Baker in Sausalito, gleaming before the backdrop of the Golden Gate Bridge. The cry of bagpipes floated over the bay where a fire boat waited for its moment — a traditional water salute. This was a memorial for Ross Valley Fire Captain Rick Addicks, and fire ladders rose toward the sky, supporting an American flag to honor the fallen 22-year veteran of the Marin County fire service. In April 2024, Addicks died of occupational esophageal cancer at age 55, one year after he was diagnosed. His wife Kristen spoke of his abiding commitment to his career and his firefighting "family," and as the firefighting community paid tribute to Addicks' life and service, it became clear that as a lawyer as well as a firefighter, he spent his career not only fighting fires, but also advocating for the physical and mental health of his fire service peers.

"We loved Rick," says Sid Jamotte, one of Addicks' younger colleagues at the Ross Valley Fire Department. "When Rick got sick, cancer became so much more real." Jamotte describes Addicks' efforts to look out for the well-being of his colleagues as non-confrontational, but inquiring and persistent. "I asked him what he would like me to do once he passed, and he said, 'Keep charging.' And I will, because that is what he did," says Jamotte.

According to Jamotte, who is now the Health and Safety Chair of the Marin Professional Firefighters Local 1775, and John Bagala, the president of the same union, the number of cancer diagnoses amongst the ranks of the 465 firefighters in the nine fire agencies across Marin County continues to rise at an alarming rate. "It used to be heart attacks, then vehicle accidents that were line-of-duty deaths for firefighters," says Bagala. "Then, in 2014, we lost more firefighters by suicide than line-of-duty deaths. On the heels of that, there has been this rise in cancer. Now cancer is the leading cause of death among firefighters. So we have to ask ourselves the question: Why do the number of firefighters diagnosed with cancer keep going up? We cannot slide backwards protecting firefighters' lives."

In December of 2020, Matthew Alba, a San Francisco Fire Department battalion chief was at his home in San Anselmo getting ready for a bike ride with his daughter when he had a seizure. His daughter, just 11 years old at the time, called 911, then ran across the street to get help. Alba was stabilized and diagnosed with incurable brain cancer. Despite dealing with chronic cancer, Alba continues to work for the San Francisco Fire Department. He has undergone treatment, including major brain surgery to remove a large tumor, and while he has not experienced physical deficits, Alba has some cognitive deficits and his communication skills have been affected by aphasia, a disorder caused by damage in the area of the brain that controls language expression. After 26 years in the field, Alba is no longer on active duty, but assumed a position as battalion chief in charge of the Division of Health, Safety and Wellness for SFFD. He is also a board member of the San Francisco Firefighters Cancer Prevention Foundation. The Foundation, founded by 30-year veteran Tony Stefani, who was diagnosed with bladder cancer in 2001, supports Northern California firefighters who are facing a cancer diagnosis and commissions science-based studies around cancer and cancer prevention.

"As long as I am working in the Fire Department, I will continue to try to protect firefighters," says Alba. One of the exercises prescribed to Alba to regain his ability to access language is to read complex material outloud. "I alternate reading poetry with reading peer-reviewed scientific journals that include the studies that tie cancer to fire service," he says. "In the past, the connection was hypothetical. Now science has confirmed it as a fact. Firefighters are the modern version of the canary in a coal mine because we are exposed to so many known carcinogens."

According to research by the Centers for Disease Control and the National Institute for Occupational Safety and Health, occupational cancer is now the leading cause of line-of-duty deaths in the fire service. The International Association of Firefighters found that nearly 75% of those honored at the Fallen Firefighter Memorial in September 2022 died of occupational cancer. Fire service representatives and legislators in many states across the U.S. are working to classify all cancers contracted by firefighters as "presumptive," meaning the disease is related directly to the occupation, something that is critical to supporting firefighters as they seek workers' compensation and disability benefits.

Firefighters have long known the risks of exposure to carcinogens in the smoke from burning buildings and in firefighting foam, but as researchers investigate possible causes for increasing rates of cancer, the PFAS (per- and polyfluoroalkyl substances) in the firefighting "turnouts" (protective gear) have been implicated. These synthetic "forever chemicals," named so because they are highly persistent in the environment, are used in industry and consumer products worldwide. Firefighting gear is particularly laden with PFAS, which are used for thermoregulation and heat and water resistance, including in the layers of clothing close to the firefighter's skin.

"We've known firefighting is one of the most dangerous jobs. We've always known. Now as science and technology progress, we have to make improvements to make ourselves more safe," say Bagala. As cancer diagnoses and deaths impact fire agencies, many leaders in the Northern California community have become increasingly vocal about the urgent need to reduce chemical exposure, and are adamant about the long-term industry knowledge of the cancer risk that PFAS pose and the need to hold manufacturers accountable. In June of 2023, 3M Company settled a \$10 billion class action lawsuit assuming accountability for the PFAS in Aqueous Film Forming Foam (AFFF), and currently a tidal wave of class action and personal injury lawsuits against manufacturers 3M, DuPont, BASF, Tyco Fire Products and others, points to manufacturers' knowledge of the grave health risks of PFAS used in foam and turnout gear. Internal documentation from as far back as 1970 confirms that the company DuPont knew that PFAS were "highly toxic when inhaled," and, in the decades since, multiple internal documents from DuPont, 3M and other manufacturers point to awareness of PFAS as "persistent," "bioaccumulative" and "toxic."

"The equipment manufacturers that make the gear we wear have been lying to us for years," says Union President Bagala. "They knew these chemicals were not safe, and, like Big Tobacco, they had a big campaign to convince us otherwise. The last thing we expected is that these manufacturers intentionally, or unintentionally, have been poisoning our people." The Local 1775 union has purchased a copy of *Burned*, a 2023 documentary film that follows the chronology of industry suppression and misrepresentation of information about the health risks of PFAS, and will hold screenings for the Marin County fire community as well as the general public in the coming year.

"A minority of people have been profiting from a majority of people suffering," says SFFD's Alba. "Companies have been making money off of these chemicals." As awareness grows among the fire service, politicians and the general public, the needle has begun to move, and California and the Bay Area are on the forefront of changemaking. In 2020, California joined 13 other states, passing a ban on PFAS compounds from firefighting foams. This law took effect on January 1, 2022. Then, last May, San Francisco became the first city in the nation to ban the chemicals from the city's firefighting gear. A local ordinance requires the city to invest an estimated \$10 million to replace firefighting turnouts by June 30, 2026. Meanwhile, in Sacramento, AB 2408 proposes a ban on the manufacturing, sale and distribution of firefighter gear that contain PFAS. The bill, authored by state Assemblymember Matt Haney of San Francisco's District 17 and sponsored by California Professional Firefighters, passed unanimously in the Assembly and is on its way to review in the Senate.

In his separate roles in the Fire Department and on the board of the San Francisco Firefighters Cancer Prevention Foundation, Alba is involved in efforts to protect firefighters by establishing health testing protocols, studying supplements such as sulforaphane for efficacy in mitigating cellular damage and finding non-toxic replacement turnouts. SFFD recently concluded a 90-day trial of PFAS-free gear made by a company called Stedfast. Unfortunately, in order to meet "vertical flame test" regulations set by the National Fire Protection Association, the gear uses a fire retardant that is also a known carcinogen, so the search for effective non-toxic turnouts continues. In Marin County, Jamotte is looking into an opportunity to replace the "bunker" gear, which is for training purposes only and does not require the same level of protection, with PFAS-free alternatives. "There is more and more stuff coming out now," he says. "A firefighter in Florida created a set of bunker gear for training with no chemicals whatsoever. We can wear these turnouts in training and we are not absorbing known carcinogens."

Jamotte, Bagala and Alba all say that the process of replacing turnouts nationwide will be a matter of public awareness, leading to political and financial will at local, state and national levels. Assemblymember Damon Connolly, who represents Marin in the California Assembly, and the North Bay's State Senator Mike McGuire, have both been vocal advocates for AB 2408. "If there is change at the state level holding manufacturers accountable, it will lead to change at the local level," says Bagala. "But this is a long-term fix. Even if we start replacing our turnouts today, there are approximately 400,000 paid professional firefighters — and each has a set of two turnouts. That is an investment, and it will take time." Bagala estimates it will take five to 10 years before fire departments across the nation see turnouts free of harmful chemicals.

Josh McHugh of San Anselmo and Rick Addicks were best friends for three decades. Both were fire captains — McHugh in the Southern Marin Fire District and Addicks at the Ross Valley Fire Department. They worked together, surfed together, skied together and raised their families together. "I lost the best friend I ever had," says McHugh of Addicks' death in April. Something else the two men shared is a cancer diagnosis. McHugh was diagnosed with occupational colorectal cancer on Cinco de Mayo, 2020, at age 51, which forced him to retire after 26 years in the fire service. "I loved firefighting so much, and I miss it terribly," he says. "When I hear a siren go by I still wonder what is going on. I cherish every moment of my career." After treatment and surgery, McHugh's cancer is in remission, but he continues to face post-treatment health challenges.

Because the transition to non-toxic gear will take time, McHugh believes it is critical that fire agencies establish other immediate ways to protect firefighters. "Trying to get manufacturers to change their products is very slow," says McHugh. "So we need health screenings, preventative care and awareness. And there are also simple changes we can make. For example, we used to just have one set of turnouts. Now we have multiple. We need to bag up our dirty stuff, and we need to have decontamination stations on the scene."

Bagala and Jamotte echo McHugh, saying that establishing decontamination protocols and, most importantly, regular health screenings to diagnose early, before cancer spreads, are the immediate actions Marin County fire agencies can take. "There are hundreds of things to do, but occupational testing will save lives and careers. Testing for these cancers — colon, esophageal, breast, prostate, brain, thyroid — so we catch them early. It is a lot cheaper to do the tests now than to treat our people later," says Bagala.

Regular testing will cost an estimated \$2500 per firefighter, says Jamotte. He believes that Marin County taxpayers want to know that the people they rely on in residential fires and wildfires, who deliver babies, rescue them from waves and save them from heart attacks, among other emergencies, are taken care of and are healthy. So the key is that fire chiefs allocate the funds for these measures. "A budget is a moral document," Jamotte adds. "We can spend a fraction of our budget so that every year our firefighters get a clean bill of health. If we catch one case of cancer at stage one, instead of stage four, which was what Rick's diagnosis was, it is worth every penny because we saved a firefighter, and we saved a human being."

And a big shout out to Meahgan Pang for helping put this together. Without her assistance and support this would not have happened.




